(1) In all cases of pormotion, the continuous ad hoc service rendered in the feeder post, if any, prior to regular appointment to the post shall be taken into account towards the length of service as prescribed in these rules for promotion subject to the condition that the ad hoc appointment/promotion in the feeder category had been made after following proper acceptable process of selection in accordance with the provisions of R& P Rules, provided that in all cases where a junior person becomes eligible for consideration by virtue of his total length of service (including the service rendered on ad hoc basis, followed by regular service/appointment) in the feeder post in view of the provision referred to above, all person senior to him in the respective category/post/ cadre shall be deemed to be eligible for consideration and placed above the junior person in the field of consideration:

Provided that all incumbents to be considered for promotion shall possess the minimum qualifying service of atleast 3 years or that prescribed in the R&P Rules for the post, whichever is less:

Provided further that where a person becomes ineligible to be considered for promotion on account of the requirements of the preceding proviso, the person(s) junior to him shall also be deemed to be ineligible for consideration for such promotion.

Explanation.—The last proviso shall not render the junior incumbent(s) ineligible for consideration of promotion if the senior ineligible person(s) happened to be ex-servicemen recruited under the provisions of Rule-3 of Demobilized Armed Forces Personnel

(Reservation of Vacancies in Himachal Technical Services) Rules, 1972 and navidy been given the benefit of seniority thereunder or recruited under the provisions of Rule 3 of Ex-Servicemen (Reservation of Vacancies in the Himachal Pradesh Technical Services) Rules, 1985 and having been given the benefit of seniority thereunder.

(2) Similarly, in all cases of confirmation continuous ad hoc service rendered on the feeder post, if any, prior to the regular appointment/promotion against such post shall be taken into account towards the length of service, if the ad hoc appointment/promotion had been made after proper selection and in accordance with the provision of the R & P Rules:

Provided that inter-se seniority as a result of confirmation after taking into account, ad hoc service rendered as referred to above shall remain unchanged.

A candidate for appointment to any service or post must be a citizen of India.

Selection for appointment to the post in the case of direct recruitment shall be made on the basis of vivavoce test if the Himachal Pradesh Public Service or other recruiting authority, as the case may be, so consider necessary or expedient by written test or practical test, the standard/syllabus etc. of which will be determined by the Commission/other recruiting as the case may be.

The appointment to the service shall be subject to orders regarding reservation in the service for Scheduled Castes/Scheduled Tribes/other Backward Classes/Other categories of persons issued by the Himachal Pradesh Government from time to time.

Every member of the service shall pass a departmental Examination as prescribed in the Departmental Examination Rules, 1997 as amended from time to time.

Where the State Government is of the opinion that it is necessary or expedient to do so, it may, by order for reasons to be recorded in writing and in consultation with the Himachal Pradesh Public Service Commission, relax any of the provision(s) of these Rules with respect to any Class or Category of person(s) or post(s).
