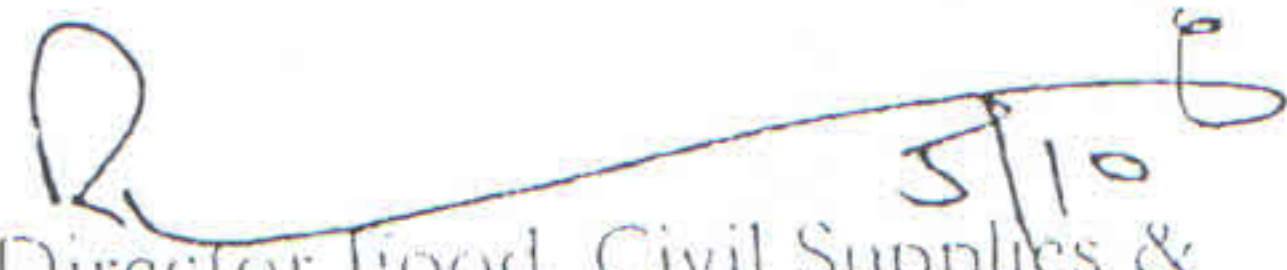
On the foregoing subject it is intimated that the Government of Himachal Pradesh has approved policy for enrolment/registration of Roller Flour Mill/ Atta Chakki with department of Food Civil Supplies & Consumer Affairs for grinding of Wheat under TPDS & Policy for allocation of wheat for grinding to the Roller Flour Mills/ Chakkies under TPDS vide letter No. FDS F(04)03/2009 dated 25-08-2015, copies of which are enclosed herewith.

ANNEXURE-B

Policy for enrolment/registration of Roller Flour Mill/ Atta Chakki with department of Food Civil Supplies & Consumer Affairs for grinding of Wheat under TPDS

The Roller Flour Mills/ Chakkies are required to fulfil the following criteria for enrolment/registration with the Department of Food, Civil Supplies & Consumer Affairs:-

1. The Roller Flour Mill /Chakkie should be registered with the department of Industries, HP.
2. The Roller Flour Mill /Chakkie should have following machineries for cleaning & washing of wheat :-
 - a. Pre-Cleaning Separator with dust Cyclone
 - b. Rotary grain separator with cyclone ✓
 - c. Intensive Scorer
 - d. Vibro Separator ✓
 - e. Dry -de-Stoner ✓
 - f. Intensive Damper
 - g. Grain Brush/ Scorer Machine
 - h. Rotary Vibro Separator
 - i. Online Magnets
 - j. Air lock/Low pressure fans
 - k. Electric Motors
3. The Roller Flour Mill /Chakkie should have following machineries in milling section:-
 - a. Roller Mills Body or Chakkie ✓
 - b. Electric Motors ✓
 - c. Pneumatic System or lift
 - d. Plan Sifters ✓
 - e. Filter or Jet Filter
 - f. High Pressure fans
 - g. Air cyclone
 - h. Micro Feeder

- ✓ 4. The Roller Flour Mill / Chakkie should have minimum 120 KV electricity load and they shall have to submit power availability certificate from the HP State Electricity Board.
5. Preference shall be given to the Roller Flour Mill / Chakkie installed near the Public Distribution Centre of Food Corporation of India.
- ✓ 6. The Roller Flour Mill / Chakkie should have minimum storage capacity of 200 MTs for storage of wheat & wheat products for PDS.
7. The Roller Flour Mill / Chakkie should have valid GST & CST registration numbers.
- ✓ 8. The Roller Flour Mill / Chakkie shall have to submit NOC from HP Pollution Control Board.
9. The Roller Flour Mill / Chakkie shall have to submit grinding capacity certificate from the department of Industries, H.P.
10. The Roller Flour Mill / Chakkie should have licence under H.P Trade Articles (Licensing & Control) Order, 1981 and licence under Food Safety & Standards Act, 2006.
11. The Roller Flour Mill / Chakkie shall have to apply to the concerned Distt. Controller, Food Civil Supplies & Consumer Affairs on the prescribed "Proforma" along-with all relevant documents.
12. Before sending the case regarding registration / enrolment of new Roller Flour Mill/Atta Chakkie to the Director, FCS&CA, the concerned Distt. Controller, FCS&CA shall consider the financial viability of the proposed as well as the existing Roller Flour Mill/ Chakkie.
13. The concerned Distt. Controller, Food Civil Supplies & Consumer Affairs shall recommend the case to the Director, FCS&CA, H. P. Shimla-9 along-with the spot inspection report of concerned Inspector, FCS&CA with regard to the requirement / feasibility of the grinding of wheat and the capacity of the mill / Chakkie etc. and along with all the relevant documents.
14. The Director, Food Civil Supplies & Consumer Affairs, HP Shimla shall enrol / register the RFM/ Atta Chakkie for grinding of wheat under TPDS after completing all codal formalities.
15. The Roller Flour Mill/Chakkie shall deposit registration fee of Rs. 10,000/- with the department of FCS&CA.

16. The Roller Flour Mill/Chakkie shall deposit Rs. 5000/- as renewal fee of registration after every five year with the department of FCS&CA with the recommendation of the District Controller, FCS&CA of concerned Distt.

17. In case any of the mandatory machineries found non-functioning at the time of inspection, action for suspension/cancellation of the registration shall be initiated.

18. All the Roller Flour Mills/Atta Chakkies already registered with the department of FCS&CA shall fulfil all the conditions of the registration policy within the three months. If any RFM/Chakkie shall not fulfil all the conditions of the registration policy within three months then the wheat under TPDS shall not be allocated to that RFM/Chakkie and the registration of mill and Chakkie shall stand suspended till six months and if the compliance not made for six month the registration shall be cancelled.

partment, the following Steps shall have to take:-

1. The Roller Flour Mill/Atta Chakkie shall have to obtain the authorisation under the H.P specified articles (Regulation of Distribution) Order, 2003.
2. The RFM/ Chakkie shall have to enter into an agreement as approved by the department of FCS&CA, with the State Agency i.e. HP State Civil Supplies Corporation Ltd. for the grinding of wheat and supply of wheat atta under TPDS.
3. The RFM/ Chakkie shall deposit a security amounting of Rs. 50,000/- with the Managing Director, HP State Civil Supplies Corporation Ltd. Shimla.
4. The agreement shall be executed during the month of March and shall be valid for the next financial year i.e. up to 31st March.
5. The concerned District Food, Civil Supplies & Consumer Affairs shall recommend the transportation and other incidental charges to the Director FCS&CA after approval of the concerned District Magistrate.
6. The ex-mill rate shall be fixed by the Director, Food Civil Supplies & Consumer Affairs keeping in various cost factors.
7. In case of inter-district movement the transportation rates may be forwarded by the concerned District Controller FCS&CA to the Director, Food Civil Supplies & Consumer Affairs for approval.
8. The Roller Flour Mill/Atta Chakkie shall have to comply with the instructions of the Department of Food, Civil Supplies & Consumer Affairs and H.P. State Civil Supplies Corporation Ltd. issued from time to time.
9. After fulfilling the above conditions the Director Food, Civil Supplies & Consumer Affairs, H.P., Shimla shall allocate the TPDS wheat for grinding to the registered RFM/Atta Chakkie.
10. The RFM/Atta Chakkie shall submit monthly reports well in time to the department of FCS&CA and HPSCSC Ltd.
11. The RFM/Atta Chakkie shall upload all necessary data/report in the website/software of the department of FCS&CA and HPSCSC Ltd.

ANNEXURE-C

Policy for allocation of wheat for grinding to the Roller Flour Mills/
Chakkies under TPDS:-

1. The Director, FCS&CA, HP shall make District-wise and Roller Flour Mills/Chakkies-wise allocation of wheat for grinding under TPDS keeping in view of the following parameters:-
 - a) Grinding / Storage capacity of the Roller Flour Mills/ Chakkies;
 - b) Minimum approved F.O.R. rates for supply of wheat atta;
 - c) Financial position of the Roller Flour Mill/ Chakkie;
 - d) If any Mill/Chakkie supplies wheat atta below prescribed standards then the Director may reduce/suspend the allocation of that Mill/Chakkie and in case of repeated failure of samples of wheat atta the Director FCS&CA shall have the power to cancel the authorization or blacklist the Mill/ Chakkie for further allocation;
 - e) If any mill/Chakkie fails to do the financial arrangements of wheat well in time then the Director FCS&CA may divert the allocation of wheat of that mill to other mill.
 - f) If the stocks of wheat are found surplus in any district due to less demand of wheat atta then the Director FCS&CA may divert such wheat stocks to other district.
 - ✓g) If any RFM/Chakkie does not supply wheat atta to the State Agency well in time then the Director FCS&CA may impose cut on the allocation of that RFM/Chakkie in the succeeding month.
 - h) If the sample of wheat atta fails due to extraction of Suzi & Maida then heavy penalty will be imposed on the RFM/Chakkie.
 - i) If the RFM/Chakkie does not make available closing balance of wheat & atta to the Directorate on the last day of the month then the allocation for succeeding month shall not be made to that RFM/Chakkie.
2. The District Controller, FCS&CA of the concerned district shall make Godown-wise sub-allocation of wheat atta keeping in view the minimum approved F.O.R. rates and as per the demand of the ration card holders of the area with a copy to the Directorate.
3. The Inspector Food, Civil Supplies & Consumer Affairs of the concerned area shall make Fair Price Shop wise sub allocation of wheat atta or shall issue permits to the FPS.

(2)-1/97-IV-16500 दिनांक 21.08.2020 के संदर्भ में आटे की पिसाई हेतु नई मिल/चक्की के पंजीकरण हेतु निर्धारित नीति में निम्नलिखित अतिरिक्त शर्तों को सम्मिलित करने की स्वीकृति प्रदान करने का निदेश हुआ है:-

1. किसी जिले में नई मिल/चक्की के पंजीकरण हेतु विभाग को आवश्यकता प्रतीत होने पर विभाग द्वारा सम्बंधित जिला नियंत्रक की सिफारिश के उपरान्त (जिसमें की नई मिल पंजीकृत करने के कारण/ औचित्य पूर्ण तथ्यों सहित होने चाहिए) प्राप्त होने वाले मिलों के आवेदनों में से मिल/चक्की का पंजीकरण सरकार द्वारा निर्धारित नीति अनुसार किया जाएगा ।
2. नई मिल/चक्की के पंजीकरण हेतु केवल वह मिल/चक्की ही पात्र मानी जाएगी, जिसे खुले बाजार में कार्य करते हुए कम से कम तीन वर्ष का अनुभव हो तथा अनुभव का प्रमाण पत्र मिल को उद्योग विभाग या उत्पाद शुल्क एवं कराधान विभाग (Excise and taxation Department) से लेना होगा। वर्तमान में जिस जिला में कोई भी मिल विभाग के पास पंजीकृत नहीं है उस जिला में नई मिल के पंजीकरण हेतु व जो मामले विभाग के पास वर्तमान में विचाराधीन है, उन पर यह शर्त लागू नहीं होगी ।
3. यदि कोई भी मिल/चक्की विभाग द्वारा दिए गए गंदम के आबंटन तथा मांग के अनुसार गंदम आटे की पूर्ण मात्रा निर्धारित समय तथा मांगानुसार उपलब्ध करवाने में असमर्थ रहती है तो उसके पक्ष में तीन माह के लिए गंदम का आबंटन बंद रखा जाएगा । सम्बंधित जिला नियंत्रक, खाद्य एवं आपूर्ति अधिकारी, निरीक्षक, खाद्य एवं

In case allotment of a Flour Mill is increased and it falls in the next slab, that Flour Mill will have to deposit security amount at increase rate for that slab. Further, in case of any diversion by the Flour Mills, if amount of recovery is more than the amount of FDR, interest accrued, if any, shall also be forfeited.
